Job Purpose

- To lead the curriculum within The Connect, our inclusion provision for KS3 and KS4, in order to support these pupils to embed the knowledge, skills and attitudes needed for a successful return to mainstream lessons. Our cohort of around 20 pupils across KS3 and KS4 are placed in The Connect for intervention programmes, typically of 12-24 weeks. Many of these pupils have low levels of literacy and numeracy as well as low self-esteem. The Connect provides them with a bespoke programme of support, mentoring and intervention. Much of the KS4 programme is delivered by curriculum departments from across the school, whilst the KS3 programme is mainly delivered directly by Connect staff.
- To lead the promotion, direction and oversight of high standards of pupil behaviour through effective group and individual support within the context of the Inclusive Provision for Key Stage 3.
- To lead the promotion, direction and oversight of high standards of pupil behaviour through effective group and individual support within the context of the Inclusive Provision for Key Stage 4.
- To teach students within our Inclusive provision with a specific focus on Key Stage 3.
- To lead and run the twilight provision after school between 3 5pm with the support of the pastoral team.
- Responsible for evaluating strategies utilised within the Inclusive Provision and that those which are effective are fed into the main school ethos to support student progress when accessing the main site.
- To work closely with the Behaviour and Pastoral Manager to ensure the smooth running of interventions and all interventions are tracked.
- To work closely with the pastoral team to support students in all aspects of academy life.
- Responsible for other staff when working directly in the Inclusive Provision or external agency staff when using the Inclusive Provision.

Duties and Responsibilities



Strategic direction and development:

- Support the vision, ethos and policies of the academy which secure effective and successful learning and promote high levels of achievement and self-esteem for all pupils irrespective of background, ethnicity or disability;
- Develop and manage a referral system for the inclusive provision, ensuring that interventions are timely and managed effectively.
- Work closely with pupils and their families to ensure that any provision addresses appropriate need. This includes ensuring that the Ordinarily Available Provision is fully utilised.
- Lead and manage the Inclusive Provision, evaluate the effectiveness of it and analyse its impact on pupils who have accessed it. This will include leading the curriculum within the provision, ensuring pupils have access to a broad and balanced curriculum which is suitable for their needs.
- Ensure the effective and proficient use of pupil data using the academy's assessment policy to raise achievement
- Raise standards of individual pupil achievement and ensure that good attainment is maintained by providing a model appropriate behaviour and social skills
- Ensure that parents are well informed about the curriculum, targets, individual pupils' progress and achievement;
- Develop and maintain good relationships with parents, outside agencies and the local community.

Recording and assessment

- Set targets for raising achievement among pupils accessing the provision
- Collect and interpret specialist assessment data; including behaviour
- Set up systems for identifying, assessing and reviewing the needs of children accessing the provision
- Create Pastoral Support Plans for individuals and ensure that staff working closely with individuals are informed of any changes to provision through this
- Update the Vice Principal on the effectiveness of provision for pupils
- Develop understanding of learning needs and the importance of raising achievement among pupils
- Attend appropriate meetings and keep parents informed about their child's progress.

Leadership



- Lead and manage the Inclusive provision and key members of staff.
- Provide and undertake training opportunities for a range of staff at the Academy.
- Disseminate good practice in assertive discipline across the Academy;

Working with colleagues and other relevant professionals

- Communicate effectively with other staff members and pupils, and with parents and carers under the direction of the class teacher
- Take the lead with outside agency support to ensure a coordinated response to provision
- Communicate their knowledge and understanding of pupils to other school staff and education, health and social care professionals, so that informed decision making can take place on intervention and provision
- Develop effective professional relationships with colleagues

Whole-school organisation, strategy and development

- Contribute to the development, implementation and evaluation of the school's policies, practices and procedures, to support the school's values and vision
- Make a positive contribution to the wider life and ethos of the school
- Ensure that pupils work together positively and co-operatively, with good behaviour in line with the school's policy and procedures.
 - Encourage and promote the social and emotional development of pupils

Professional development

- Help keep their own knowledge and understanding relevant and up to date by reflecting on their own practice, liaising with school leaders, and identifying relevant professional development to improve personal effectiveness
- Take opportunities to build the appropriate skills, qualifications, and/or experience needed for the role, with support from the school
- Take part in the school's appraisal procedures
- Attend meetings and training sessions as required.

Personal and professional conduct

- Uphold public trust in the education profession and maintain high standards of ethics and behaviour, within and outside school
- Have proper and professional regard for the ethos, policies and practices of the school, and maintain high standards of attendance and punctuality
- Demonstrate positive attitudes, values and behaviours to develop and sustain effective relationships with the school community

The Trust

- All staff are expected to follow (and ensure students follow) the procedures as laid

 follow Trust policies with regard to professional conduct when using ICT systems or
 Trust ICT equipment.
