Job Purpose

- To enforce standards around attendance to lessons and behaviour and culture so that each student can be their best self.
- To be a lead professional in the implementation and modelling of the Behaviour and Culture policy and associated system(s).
- To make a daily demonstrable difference to the academy being a calm, predictable and respectful environment.
- To make a strong contribution to a culture of excellent practice in relation to safeguarding young people.

Duties and Responsibilities

- Promote positive values, attitudes and good student behaviour including addressing students whose behaviour does not meet the expectations within the behaviour policy through working as part of the 'patrol team' and maintaining a strong presence around the site
- Role model implementation of the Behaviour and Culture policy and use of systems, for staff and students
- Understand how to use relational practice and use it to build community and empathy
- Be relentless in monitoring the behaviour of students and ensuring that appropriate follow up takes place by all members of staff where misbehaviour, or serious misbehaviour, occurs
- Create and apply intervention strategies for individuals or groups of students to remove barriers to learning
- Ensure that students who are experiencing difficulties as a result of issues at school, or at home, are given whatever support they need by the school to help them through difficult times
- Act as a mentor for students who are underachieving in relation to their targets
- Support with restoring student behaviour and relationships to the expected



standards, helping to create an atmosphere of mutual respect and courtesy

- Ensure that students who have restored their behaviour are given the opportunity to continue their learning in the classroom, supporting within this setting
- Where necessary, collect and supervise students in the inclusion provision ensuring that they follow the rules of the inclusion room and/ or of the pastoral support hub
- Conduct investigations into student behaviour that meet the expected standards and produce serious incident packs
- Meet with parents to hold intervention/re-integration meetings and ensure that appropriate intervention plans are developed and implemented
- Log information in the school IT systems in a timely manner
- Carry out duties such as break, lunch, before and after school as required
- Assist with the administration and escorting of students to alternative suspensions
- Provide work for students who are suspended and ensure that it is collected and marked by their teachers
- Assist in supporting the welfare and wellbeing of students - this includes administering first aid

Generic Duties relevant to all members of Staff

Working with colleagues and other relevant professionals

- Ensure that information shared by the safeguarding team is acted upon
- Liaise with SEND and attendance team and attend meetings as appropriate, reviewing and updating support plans and Pupil Passports in a timely and routine way
- Liaise with senior pastoral staff and cascade information to other staff where appropriate
- Collaborate and work with colleagues and other relevant professionals within and beyond the school
- Develop effective professional relationships with colleagues

Whole-school organisation, strategy and development

- Contribute to the development, implementation and evaluation of the school's policies, practices and procedures, so as to support the school's



values and vision

- Make a positive contribution to the wider life and ethos of the school
- Ensure that pupils work together positively and co-operatively, with good behaviour in line with the school's policy and procedures.
- Encourage and promote the social and emotional development of pupils

Professional development

- Help keep their own knowledge and understanding relevant and up-to-date by reflecting on their own practice, liaising with their line manager and identifying relevant professional development to improve personal effectiveness
- Take opportunities to build the appropriate skills, qualifications, and/or experience needed for the role, with support from the Trust
- Take part in the Trust's appraisal procedures
- Attend meetings and training sessions as required

Personal and professional conduct

- Uphold public trust in the education profession and maintain high standards of ethics and behaviour, within and outside school
- Have proper and professional regard for the ethos, policies and practices of the Trust, and maintain high standards of attendance and punctuality
- Demonstrate positive attitudes, values and behaviours to develop and sustain effective relationships with the Trust community
- Respect individual differences and cultural diversity

The Trust

- The ethos of our Trust is "Transforming Life Chances". All staff are expected to be committed to this aim in everything they do.
- It is expected that all staff work collaboratively as members of the Trust to share good practice, resources and ideas and realise the Trust's visions and aims. All staff should act with professional integrity at all times, following the "Code of Conduct".
- You will be based at TSAT Hub. However, you may be asked to work at any of the other Hubs within the Trust and you should expect to travel between sites as required.



Teaching and Learning

- This is our core business and therefore it is an absolute priority. You are expected to support all teaching staff, irrespective of seniority, to ensure they concentrate on the core business. This may mean undertaking tasks outside of your area of responsibility where required.

ICT

- It is expected that all teaching and support staff follow the ICT Vision of the Trust.
- All staff will be expected to utilise ICT and to improve communication and reduce paper use. Security procedures must be followed when using ICT systems.
- All staff are expected to follow the procedures as laid out in the Trust's Acceptable Use Policy. Staff are also expected to ensure that they follow Trust policies with regard to professional conduct when using ICT systems or Trust ICT equipment.

Health and Safety

- Employees are required to work in compliance with the Academy's Health & Safety Policies and under the Health and Safety At Work Act 1974 (as amended), ensuring the safety of all parties they come into contact with, such as members of the public, in premises or sites controlled by the Trust.
- In order to ensure compliance, procedures should be observed at all times under the provision of safe systems of work through safe and health environments, including information, training and supervision necessary to accomplish those goals.

- The Thinking Schools Academy Trust is committed to safeguarding and promoting the welfare of children and young people and all staff must ensure that the highest priority is given to following the guidance and regulations to safeguard children and young people. All staff are to have due regard for safeguarding and promoting the welfare of children and young people and to follow the child protection procedures



adopted by the Thinking Schools Academy Trust. Any safeguarding or child protection issues **must** be acted upon immediately by informing the Designated Safeguarding Lead.

Data Protection

The Trust requires all staff to complete data protection training and to adhere to its Data protection policies and procedures. All staff must ensure that if they suspect a data breach they must inform the Trust Data Protection officer immediately.
